It can provide internet connectivity at qualified service addresses, whether you're expanding locations, building network diversity, or supporting business-critical applications.

### What is “fixed wireless”?

“Fixed wireless” refers to wireless devices and services that are used in fixed locations such as an office, pop-up location, or a trailer within a construction site. This contrasts with devices and services that are mobile, such as smartphones and tablets. Fixed wireless solutions are cost effective, can be installed quickly, and can be deployed in areas where fiber internet is not available or cost prohibitive.

### Fast and reliable 5G wireless internet

AT&T Internet Air for Business can be installed in minutes at your qualified service address and can help solve multiple business challenges. It can be used to establish a wireless internet connection in remote locations or when temporary access is needed. It can also serve as a backup connection when your wired connectivity is interrupted.

Many things can affect the availability and quality of your service including, but not limited to, your proximity to the cell site, the position of your device within your location, local congestion caused by use of network capacity by high numbers of users simultaneously using data intensive applications in the vicinity of the cell tower serving your designated service address, blockage of the signal between the designated service address and the cell tower (caused by objects such as buildings, foliage, etc.), AT&T network management practices, and weather. As such, **performance, experience, and speeds will vary and are not guaranteed.** To maximize performance, you should make every effort to position your router in an optimal position for your location. **AT&T Internet Air for Business Limitations:** AT&T may engage in any reasonable network management practice to enhance customer service, to reduce network congestion, to adapt to advances and changes in technology, and/or to respond to the availability of wireless bandwidth and spectrum. In order to ensure the best quality of service for all customers using the mobility network, during times of heavy network congestion AT&T may (a) temporarily prioritize services that may be most severely impacted by congestion; and/or (b) temporarily de-prioritize and/or throttle services deemed likely to contribute to heavy congestion. **VIDEO STREAMING:** AT&T aims to render streaming video in standard definition (max of 2 Mbps for customers on both 5G-enabled devices and rate plans or 1.5 Mbps for devices or plans not compatible with 5G) though some video cannot be identified. Sometimes, other content that content providers bundle with streaming video may be impacted and slowed, including downloads. In certain situations, AT&T may deliver video content faster or at higher definition.
